

## Giving the fight against corruption a boost



Over three sessions in February, EUPOL COPPS provided training for Palestinian officials to spot possible corruption in official declarations:

"A system of asset declarations, where public officials regularly declare their sources of income and wealth, is an essential element in the fight against corruption," says Clemens Mueller, Deputy Head of EUPOL COPPS' Rule of Law Section. "We are very happy to be working with the PACC in order to build capacity in the Palestinian asset declaration system and strengthen the ability of Palestinian officials to analyse and verify the assets of public officials and make sure their sources of income are legal".

EUPOL COPPS funds major training programme on drafting legislation for Ministry of Justice officials



"Proper legislative drafting is the way in which policies are transformed into legislation. It is key to legal reform. There are a number of international best practices whenever legislation is drafted – for example processes to consult the key stakeholders affected by the legislation, as well as methods to ensure the legal text is clear, comprehensible and in line with international treaties and obligations," says Rana Bahu, EUPOL COPPS Legislative Drafting Adviser.

## "Community policing is about changing a police force into a police service"



"A community includes everyone in an area – schools, businesses, religious leaders, local government," says Carolus Janssen, a EUPOL COPPS Community Policing Advisor from the Netherlands, who has over 36 years of experience in the police. "Community policing is all about the police responding to the needs of the community and being part of the community as a whole. Community policing is very important because it is one of the ways which can change policing, turning it from a traditional police force into a modern police service. As a police officer, you need to have a language for listening as well as a language for enforcing the law".
