

### **EUPOL COPPS Newsletter - March 2020**

#### Dear friends,

Like everyone else, we are following the news about the spread of COVID-19 and thinking of all those who have been affected. Thankfully, we have had no suspected cases at EUPOL COPPS, but some colleagues have been put into preventative quarantine in line with



requirements laid down by the Palestinian and Israeli authorities due to recent travel to affected areas, such as Bethlehem. Many of our staff are teleworking and many others have had to cancel travel plans to see family and friends.

We are trying to use this period as an opportunity to move ahead with and conceptualise long term strategy and planning questions that sometimes get put on a back burner when there are day to day priorities competing for

attention. Clearly however, COVID-19 is having a significant effect on our operations – all our training sessions, workshops and study visits for our Palestinian counterparts have been postponed and it's unclear when normal business will resume.

For our part, we are fully committed to doing our bit to help stop the spread of COVID-19. The safety of our staff and the communities they come into contact with is our top priority at this moment in time. To this end, we are fully cooperating with the instructions and recommendations of the relevant Palestinian and Israeli authorities.

Before the emergency measures to counter the spread of COVID-19 came into effect, we were working at full tilt. There are therefore a number of important activities from the past month highlighted in this newsletter, with a particular focus on our training sessions to support our Palestinian partners in the fight against organised crime and also our awareness raising efforts to promote gender equality in law enforcement and rule of law institutions.

We hope you enjoy this month's newsletter and most of all hope that you and your loved ones stay safe.

### **International Women's Day 2020**



"Law enforcement and rule of law institutions are the key bodies responsible for protecting the rights of citizens, half of which are women and girls," said Kauko Aaltomaa, EUPOL COPPS Head of Mission in the run up to International Women's Day. "In order to protect the rights of all members of society, it is crucial that the agencies set up to protect and serve communities are more representative of society as a whole. Currently, only 5% of people working in Palestine's 14 security institutions are women. While the number of women working in such structures has increased recently, more can be done to make them fully representative of the people they serve".

## Strengthening the fight against organised crime

Organised crime undermines the foundations of a society and can corrupt all levels of a community. Criminal groups are becoming increasingly sophisticated, including by using technology to conduct operations and evade law enforcement.

In February 2020, EUPOL COPPS delivered two trainings on organised crime for Palestinian counterparts - one on cybercurrencies and the other on the principles for developing a comprehensive and effective strategy for combatting organised crime.
